Product description

Alcohol-based broadband skin and hand disinfection with a quick effect on the basis of 2-propanol without the addition of colours and scents for use in the medical field, but also adequate for handling with food. Fast-acting skin disinfection on the basis of 2-propanol. Pharmaceutical authorised for the hygienic and medical hand and skin disinfection. Listed with the VAH (Verbund für Angewandte Hygiene e.V.) acc. to the guidelines of the DGHM (Deutsche Gesellschaft für Hygiene und Mikrobiologie e.V.). Free of skin allergens and additional irritants. The product does not cause any allergies. Specific adequacy for skin allergic persons. Applicable in accordance with § 18 IfSG (infection protection law) and RKI-disinfection list (Robert Koch Institut). Spectrum of activity: bactericidal incl. TBC, fungicidal, viricidal (HIV/HSV/HCV/influenza/noro).

Fields of application

For skin and hand disinfection in the medical area, but also for handling with foodstuffs. Pharmaceutical authorised for the hygienic and medical hand and skin disinfection, skin disinfection before simple injections and punctures of peripheral vessels, skin disinfection before operations and before punctures of joints, disinfection of skin with high sebaceous glands as well as for medical cooling compresses. Skin disinfection in the medical and maintenance area.

Dosing instructions

For hygienic hand disinfection rub in hands with the solution and keep it wet for 30 seconds. For medical hand disinfection rub in hands and forearms with the solution and keep it wet for 3 minutes. Effective according to certificate by Prof. Werner already after 1.5 minutes. For disinfection of simple injections and punctures of peripheral vessels rub off the skin carefully with the solution and keep

it wet for 15 seconds. For disinfection before operations and punctures of joints rub off the skin with the solution and keep it wet for 1 minute. For disinfection of highly sebaceous skin the solution is to rub in and the skin is to be kept wet for 10 minutes. For cooling compresses the solution is to apply diluted with water in equal parts. The time specifications are minimum times. Depending on additional difficulties (e.g. wet skin, contamination on the skin, risk of intervention) the residence time is to extend. RHEOSEPT Hand disinfection does not act sporicidal and is therefore not adequate for the custody of sterile instruments and injections.

Composition

100g solution contain: as medical effective component: 2-propanol 63,1g (70V%). Excipient: cleaned water. 2-propanol-based.
